The Kierson Riding Academy teaches lessons by appointment only 7 days a week on farm owned school horses. We also offer participation in local fun shows and tournaments in addition to our Academy and Show Teams. Kierson Farm's instructors are dedicated to creating a safe atmosphere of learning and responsibility for all students, ensuring a positive and productive introduction to horses.

Kierson Farm owns many seasoned lesson horses to babysit the smallest of rider and to challenge the most accomplished equestrians!

**Memberships include once a week lessons per person.**

**Payment is due at time of registration and renews automatically each month unless canceled.**

**All lessons are by appointment and times depend on availability. Please call or email to register or schedule lessons.**

**Private Membership: \$325**

Lessons are 30 minutes while riders are one on one with the instructor. Private lessons are perfect for the rider who is looking for a more intense and serious approach to riding.

**Tiny Tot Membership: \$225**

Private Lessons for riders 3-6 years old. Lessons include 20 minutes of riding and 10 minutes of grooming and horse time.

**Mommy and Me Membership: \$325**

Great private lesson for parent and tiny tot rider to spend time together doing a fun activity. 20 minutes of riding.

**Private Type Lessons are offered  
Weekdays 1-5 (Tuesday until 7) and Sunday 9-12**

**Group Membership: \$275**

Group lessons are offered for all ages. Lessons are 1 hour in length, with 45 minutes of riding time and 15 minutes grooming and horse care. Group lessons are offered for all level riders. Group lessons are a great way to gain experience or increase you endurance and fitness level.

**Academy Membership: \$575**

The Academy Package designed for the rider who is ready to begin competing. The package consists of 1 group and 1 private a week.

**Lunge Lessons/Yoga on Horseback: \$35 each**

Great way to gain strength throughout whether you need to get in shape for riding or just get in shape. Lessons work on core, upper body, legs and balance.

**Group Type Lessons are offered Mondays at 5pm and 6pm,  
Wednesdays at 6, Friday at 5 and 6 and Sunday 12pm.**

**Please Note:** Lessons will not carry over to the following month. All cancellations must be made 24 hours in advance for make up. Any rider not dressed appropriately or not scheduled will not ride. Times will be made available for make ups if cancellation is necessary.

Understanding those risks I/we hereby release Kierson Farm LLC., N & H Saddlebred Holdings LLC, Megan Harrison,, it’s officers, directors, shareholders, employees, and anyone else directly or indirectly connected with that farm from any liability whatsoever in the event of injury or damage of any nature (or perhaps even death) to me or anyone else caused by or incidental to my electing to handle, mount or ride a horse. I/we also understand that while on property, I am considered a participant in equine activities that can be hazardous.

**I/we** understand and recognize and warrant that this Release and Hold Harmless Agreement, is being voluntarily and internationally signed and agreed to, and that in signing this Release and Hold Harmless Agreement I know and understand that this Release and Hold Harmless Agreement may further limit the liability of equine professionals to include any activity, whatsoever, involving an equine, including death, personal injury and/or damage to property. I/we recognize and agree that I know which equine professional(s) I will be working with, and acknowledge that I agree said equine professional(s) has/have made reasonable and prudent efforts to determine my ability to engage in the equine activity and has/have sufficient knowledge of my equine and horseback professional(s) from any continuing duty to monitor my equine activities. I/we further voluntarily agree to warrant to Release and Hold Harmless Kierson Farm LLC., N & H Saddlebred Holdings LLC, Megan Harrison, any liability whatsoever, including , but not limited to any incident caused by or related to said equine professional(s) negligence, relating to injuries known, unknown, or otherwise not herein disclosed; including, but not limited to injuries, death, property damage from: mounting, riding, dismounting, walking, grooming, feeding, leading, holding, use of horse barn, paddock, trails, indoor arena, outdoor arena, arena, or horse ring in any capacity; falling off horse whether horse is bucking, flipping, spooked,; or my failure to understand any equine professional’s directions relating to my riding or otherwise use and control, or lack thereof, of my horse or any other horse I am associated with.
